TEAM MANAGERS MEETING

October 30, 2025 08:00 PM at the venue (transport from the official hotel will be provided 10 min before the meeting time).

ELIGIBILITY

Players who are under 17 years of age throughout the year 2025 (i.e. born in 2009 or younger) and who are eligible to play for BWF Members.

EVENTS

Men's Singles, Women's Singles, Men's Doubles, Women's Doubles, Mixed Doubles. The numbers of players/pairs to be accepted for the main events are 64 in Singles, 32 in Doubles and 48 in Mixed Doubles.

In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.

Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

ENTRIES

All entries must be made by using the BWF Online Entry System: <u>https://bwf.tournamentsoftware.com/tournament/E7ADE8DC-AACB-4C56-95F1-5D4F89B4639D</u>

Players cannot be entered unless they already have a BWF ID-number. In case you wish to enter players, who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

Entries must be submitted no later than Tuesday, September 30, 2025 4:59 PM (GMT +1). No late entries will be accepted.

GCR 7.9: "In making or authorising entries, the Member concerned its reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

ENTRY FEES

Singles - 40€ per player; Doubles – 35€ per player

According to BEC U17 Circuit Regulations "12.1 The Member that enters a player/pair into a BEC U17 Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payments at tournaments.

12.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member.

12.5 Organisers are allowed to refuse entries if Members or their players have outstanding fees from a previous year."

Please ensure that the Organizer is informed immediately when a player has to withdraw, preferably together with the reason.

CONDITIONS OF PLAY

The Tournament will be conducted under the laws and competition regulations of the BWF and the Regulations of the Badminton Europe U17 Circuit, including the prohibition of doping for which tests may be carried out. According to Portuguese law, Drug Testing may be carried out on a random basis throughout the tournament.

§ 13.1 of the BEC U17 Circuit Regulations: "Colour, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16."

§ 13.2 of the BEC U17 Circuit Regulations: "For all BEC U17 Circuit tournaments the name on the back of the shirt is optional."

TRANSPORT

Transport will be provided free of charge between Lisbon International Airport and Caldas da Rainha (80 km) only for participants who booked hotel through the organization using official form. Participants who don't book hotel through the organization may request airport transport, but it will have a cost of 100€ per person (both ways).

Transport between the official hotels and the hall will also be provided free of charge during the tournament.

ACCREDITATION

Accreditation will be available on-site on the first day of the tournament. No form is required.

All participants must go to the Info Desk at the venue to collect their accreditation.

Please note that accreditation is mandatory to access the field of play.

GYM

The gym at the venue will be available from 08:30am to 08:30pm. Closed on Sunday. Players may use the facility by paying:

- €10 per day, or
- €25 for 3 days (Thursday, Friday, and Saturday).

Payment is to be made on-site at the Gym Info Desk.

CATERING

Lunch and dinner available in the Sports Centre Restaurant. The price is 15€/meal (includes soup, main course – meat, fish or vegetarian option – salad, drink and dessert or fruit).

DOPING CONTROL

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted outof-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

BADMINTON INTEGRITY

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).

Badminton Europe is not liable for any such claims, actions, damages, costs or expenses of any nature whatsoever, including but not limited to injury or loss to person or property, arising out of or in any way related, directly or indirectly, to the particular BEC U17 Circuit tournament. It is recommended that Members and/or Organisers purchase a proper Insurance Policy that would cover their potential legal liability.

The organizer declines responsibility and covering of costs for possible injuries or other damages. It is up to each participant purchases a proper insurance.

TOURNAMENT CANCELLATION

The organizing Member can cancel a tournament in case of force majeure or due to too few entries in at least one of the events. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member organizing the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). Badminton Europe is not liable for any costs incurred by third persons because of a cancellation of a tournament.
