TEAM MANAGERS MEETING

November 26, 2026 08:00 PM at the venue (transport from the official hotel will be provided 10 min before the meeting time).

ELIGIBILITY

Players who are under 19 years of age throughout the year 2026 (i.e. born in 2008 or younger) and who are eligible to play for BWF Members.

EVENTS

Men's Singles, Women's Singles, Men's Doubles, Women's Doubles, Mixed Doubles. The numbers of players/pairs to be accepted for the main events are 64 in Singles, 32 in Doubles and 48 in Mixed Doubles.

In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.

Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

ENTRIES

All entries must be made by using the BWF Online Entry System:

Players cannot be entered unless they already have a BWF ID-number. In case you wish to enter players, who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

Entries must be submitted no later than Tuesday, October 27, 2026 3:59 PM (GMT +0). **No late entries will be accepted.**

GCR 7.9: *"In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."*

ENTRY FEES

Singles - 40€ per player; Doubles – 35€ per player

According to BEC Junior Circuit Regulations

"§ 12.1 The Member that enters a player/pair into a BEC Junior Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payments at tournaments.

§ 12.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member.

§ 12.5 Organisers are allowed to refuse entries if Members or their players have outstanding fees from a previous year."

There is also the possibility to pay for entry fees in cash to the organisers when players arrive to the venue. We don't accept debit or credit cards.

CONDITIONS OF PLAY

The Tournament will be conducted under the laws and competition regulations of the BWF and the Regulations of the Badminton Europe Junior Circuit, including the prohibition of doping for which tests may be carried out. According to Portuguese law, Drug Testing may be carried out on a random basis throughout the tournament.

"§ 13.1 Colour, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalised by an administrative fine of 50,00 EUR.

§ 13.2 It is mandatory for the semi-finals and finals that partners in doubles wear the same colour of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR."

TRANSPORT

Transport will be provided free of charge between Lisbon International Airport and Caldas da Rainha (80 km) only for participants who booked hotel through the organization using official form. Participants who don't book hotel through the organization may request airport transport, but it will have a cost of 100€ per person (both ways).

Transport between the official hotel and the hall will also be provided free of charge during the tournament.

ACCREDITATION

Accreditation will be available on-site on the first day of the tournament. No form is required. All participants must go to the Info Desk at the venue to collect their accreditation.

Please note that accreditation is mandatory to access the field of play.

GYM

DOPING CONTROL

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

BADMINTON INTEGRITY

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).

It is recommended that Members and/or Organiser purchase a proper Insurance Policy that would cover their potential legal liability.

The organizer declines responsibility and covering of costs for possible injuries or other damages. It is up to each participant purchases a proper insurance.

TOURNAMENT CANCELLATION

The organizing Member can cancel a tournament in case of force majeure or due to too few entries in at least one of the events. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member organizing the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). Badminton Europe is not liable for any costs incurred by third persons because of a cancellation of a tournament.
